1. The President, Kerry McInerney, took the Chair.

#### 2. Attendance:

Eighty people, consisting of 72 members, six visitors, a speaker and his Projectionist, made up the meeting.

#### 3. Welcome:

The President welcomed the members and prospective members, as well as the visitors.

#### 4. New Members:

The President read the names of the fifteen prospective new members: Pat Ajani, Mary Amarego, Ross and Judy Chapman, Maureen Dubock, Laurene Eames, Norma. Green, Ann Jewel, Ron and Lynette McBain, Dorothy Macaulay, John and Val Reid, Val Sigg, and Pamela Young, who were accepted into the club by acclamation of the members present,

#### 5. Reports

#### 5.1 Treasurer's Report:

The Treasurer presented her report: Cash in bank \$2547.69 - full report attached, which was accepted by the meeting on a **motion** from Patricia McInerney, **seconded** by Terry Pearlgood.

#### . 5.2 Sectretary's Report:

There was no Secretary's Report, as the Secretary and his wife were holidaying overseas.

# 5.3 Vice President's Report on the Meeting of the Probus Clubs of Manningham:

The Vice President reported that four of the Committee had attended the quarterly meeting of the Probus Clubs of Manningham. Our representatives were favourably impressed by the breadth of activities of the 16 other clubs and the calibre of speakers they engaged to address their club meetings. Our club was welcomed as the most recent to be formed in the area. We presented a short verbal report on the Club's achievements so far and made several important individual contacts in other clubs in the district.

#### 6. GENERAL BUSINESS:

#### 6.1 Incorporation:

The President explained that the Committee had met following the last Club Meeting and, among other things, examined the Minute Book of Club Meetings, This revealed that at the Inaugural (or Foundation) Meeting the Club had in fact adopted the standard Probus Constitution and the recommended Probus By-Laws.

The task that remained to he completed was to secure Incorporation for the Club, he said. With a copy of the standard Probus Constitution and recommended Probus By-Laws in hand, the President read out the words, numbers and phrases pertinent to this Club and necessary to complete these documents to the satisfaction of Probus South Pacific, and the Department of Consumer Agairs, Victoria from whom we are seeking Incorporation

He then called on the Minute Secretary to read to the meeting the motion from the Inaugural Minutes regarding the Club's adoption of the standard Probus Constitution and recommended By-Laws. He then asked the Minute Secretary to read out the two duplicating motions passed in error at the last Club Meeting. This having been done, he put it to the meeting that a rescinding motion was needed to expunge the two duplicating motions from the books. The Minute Secretary obliged with the following motion;

"That the motions referring to the Constitution, By- Laws Model Rules passed at the Club Meeting on Monday, 8 September, one month ago, be rescinded forthwith." seconded Leon McGree. Carried.

Following a call from the President for a motion to accept the additions he had outlined in respect to the Constitution and the By-Laws (notwithstanding that the two documents share the same form), the Minute Secretary obliged with the following motion

'That the additions to the Constitution and By-Laws, as set out at this meeting he adopted ...... seconded Elaine Dodds. Carried.

# 6.2 Membership Reserved for Spouses:

In response to a question about the places being kept on hold for spouses not yet retired from the workform or able to join the Club immediately, the President

stated that with an upper limit of 120 member places, the last 20 were, within reason, being reserved for this purpose With the paid-up membership now standing at 94, the next meeting could close off the membership. Note; It should be made clear to members that visitors are able to join outings and functions where these are not fully subscribed to by members.

#### 6.3 Christmas Lunch:

The President informed the members that we had been unable to secure a booking with Eastern Golf Club for our Christmas function on 8 December. He called on John Mugridge to tell the meeting of the substitute arrangements: John informed the meeting that the new venue was the Yarra Valley Country Club and at less than half the cost of the earlier venue (\$12 as against \$26). As previously arranged, we would conduct a regular meeting minus a speaker and move on to the YVCC thereafter. Payment will be required by next month's Club meeting, 10 November.

#### 6.4 Activities Groups:

The President reminded members that payment was due this day for the Maldon trip, the concert All that Jazz, and for the visit to the Johnston Collection.

His clients are private and corporate decorators, interior designers, film companies and museums. He presented interesting overhead-projector images of the items traded: from tearoom tables to ticket boxes, many in huon pine, Queensland maple, cedar, kauri, and Tasmanian blackwood. He described himself as a businessman with a passion for resources recycling.

At our inaugural meeting on the 12/6/2003, The "Provisional "Probus Club of Templestowe Valley adopted the Standard Probus Club Constitution and the recommended Probus Club By-laws.

This was a "Blank" 4 page handout supplied to the Foundation members at this meeting, & subsequently made available to new members. (HOLD UP COPY FOR ALL TO SEE). These were the basic rules for operating a Probus Club as recommended by Probus H.O.

The Probus Club handbook, pages 1 &2 states; ...... "The Constitution".........

It then goes on to say this about Incorporated Clubs;....."Incorporated Clubs"....

#### (READ FROM HANDBOOK)

At this point in time we are not yet incorporated, as we did not have a Public Officer. Doug Hayne has agreed at the September meeting to be the Public Officer, and upon his return from overseas on the 24th.Oct. the committee will put its recommendations to you for acceptance, so that we can submit these Rules to Corporate Affairs for their acceptance, which will then make us an Incorporated Club, and so protect the members for Personal Liability for debts of the club.

Motion to accept Doug. Moved..... Seconded......(not formalised in Sept. Meeting)

At the last meeting in September, a further motion was passed accepting what had been previously agreed to in respect to the "Basic" constitution and by-laws, and this led to some confusion as some fundamental items had not been clearly spelled out to the members. Accordingly the committee at our last meeting held on the 18/9/03 have now identified these 'gaps' and make the following recommendations for acceptance. 4. Financial year ends 31/3/04
