John Mugridge reported that a chance encounter by him with the Charter President of Lions Club of South-East Business, Michael Rajoo, had led to the making of an executive decision by our club to request our members to donate clothing and blankets for the relief of Tsunami victims in Sri Lanka. The response from members was overwhelming, amounting to 160 large draw-string bags, with an estimated value in the range of \$8,000 to \$10,000. The clothing was sorted by the Lions Club into winter garments for sale through the Lions Op-Shop network so that the money raised could be used to aid victims, while the remainder, mostly summer clothing, was sent free through Cathy Pacific Airlines to Colombo for immediate distribution. The whole operation took about a week. Members were to be congratulated for the way they rose to the occasion.

She said that despite the rigours, she had got to like the lifestyle. Jean and her husband intend to publish a pocket book on kurrajongs, as well as a more detailed study.
