INTRODUCTION

This is the 19th Annual Report of the Probus Club of Templestowe Valley (Combined) Inc.

The Probus movement had its genesis in two ancestors – both in the UK and both established by Rotary Clubs. The first was formed in 1965 and was known as the Campus Club – its name was derived from the area of the town in which it was conceived – the Campus. The second was formed by the Rotary Club of Caterham in 1966 and was named the Probus Club for the "PRO" in professional and the "BUS" in business and which also made up the Latin word from which "PROBITY" is derived. Both were formed to meet the need for companionship of their peers and mental stimulation for retired business and professional men.

Today there are Clubs for male, female and combined gender.

The first Club in Rotary's South Pacific area was the Probus Club of Kapiti Coast, New Zealand in 1974. The first Club in Australia was the Probus Club of Hunter's Hill, NSW in 1976.

Today Probus is a world-wide movement in 25 countries.

Probus South Pacific Limited

What is now known as PSPL was formed in 1981 in Sydney when five Rotarians, all of whom had been involved in the formation of Probus Clubs came together to share their experiences. They recommended the provision of an information service to Rotary Clubs throughout the region. The result was the Probus Information Centre.

At the time of formation, it was noted that "It was important, however, that the Centre would not be a controlling body, or Probus Head Office, but rather a service or information centre." In 2010 the Board of Probus Centre – South Pacific created a new organisation to replace the Centre.

The new organisation is a company limited by guarantee, and Probus South Pacific Ltd. (PSPL) is formed under NSW law. It is a commercial organisation but simultaneously takes for itself the right to control all non-profit Probus Clubs and organisational structures in the South Pacific.

Mission

PSPL is dedicated to promoting the development of friendship, fellowship and the advancement of intellectual interests for active retirees through Probus Clubs in the South Pacific area.

Vision

The vision of PSPL is to co-ordinate the growth, development and ongoing support for Probus Clubs, as the most widely recognised organisation for active retirees, in fostering the true spirit of Probus – friendship, fellowship and fun.

Melbourne East Probus Group "MEPG" (formerly Manningham Probus Interest Group "MPIG"))

Following the death of Ken Falconer OAM (who acted as Chairman and Secretary of the MPIG), a request was sent to all member clubs to attend a special meeting convened for 29 March 2021 requesting volunteers to join the committee to enable the continuance of MPIG. The result was zero which meant that MPIG had to fold.

Subsequent offers were made to members of clubs (who were MPIG members) from outside the Manningham area to join a committee comprising Chairman, Vice Chairman, Secretary and Treasurer. In conjunction with restarting, the newly formed group name is **Melbourne East Probus Group**. Those clubs who were financial with MPIG as of March 2021 will be excused from paying fees until March 2023.

The new Group will meet each February, June and October with two delegates from each club invited to attend. Each club is requested to email a report outlining their activities. Each report will be appended to the minutes which will be sent within seven days of the meeting.

It is important that inter-action between clubs be maintained as the group meetings offer clubs information on outings, speakers and other items of interest affecting all clubs.

Probus Club of Templestowe Valley (Combined) Inc.

Currently we have 146 Club Members, including one Life Member, Doug Hayne. It is 19 years since our Club had its inaugural meeting on June 12, 2003, under the guidance of Manningham Rotarians, the late Ken Murray and Max Didier, when 62 Foundation Members signed up in the hall at the Ted Ajani Reserve.

The Club was incorporated in 2004. The Secretary holds the official position of Public Officer. By being incorporated, any litigation needs to be directed to the incorporated body and cannot be directed to individual members.

The Club meetings are held on the second Monday of every month throughout the year and commence at 9.45 am in the Ajani Centre, 284 Thompsons Road, Lower Templestowe, 3107.

Club Insurance

PSPL provides universal insurance cover for Members and third parties attending official and approved Club events. Each Club is levied an annual fee to cover this insurance. The PSPL charges an annual fee per member.

SECRETARY'S ANNUAL REPORT

Unfortunately, due to Council doing maintenance in various halls, we again had to rely on Zoom in January. February was back in the hall with no restrictions on numbers, however, QR codes, vaccination certificates and face masks were still the order of the day.

During the year, I completed the Annual Forms for PSPL regarding Capitation fees and advised of any membership changes as they occurred. Manningham City Council was notified of new addresses for office bearers and the Department of Consumer Affairs Annual Form was completed. The "Active Retirees" magazine and "Staying Connected with Probus" newsletters were forwarded to members to keep them informed of what was happening in other Probus clubs.

I received many updates during the year from the Department of Health and Human Services keeping the Club up to date with any changes as they were announced by the government. At the end of October, a "Covid Safe Plan" was completed to gain access to the Ajani Hall. This meant a Covid Check-In Marshall had to be assigned to ensure each person used the Services Victoria QR Code and had their vaccination status verified.

Thank you letters from recipients of the wonderful work of the craft group were received and some via email were responded to. Letters were also sent to members who have resigned during the year thanking them for their participation and contribution to the Club.

As no-one from our Club could attend the two MPEG meetings, reports were sent detailing our Club's activities and speakers during the last few months. These were included in the Minutes along with activity reports from other clubs in the region.

I would like to thank the Management Committee, especially Minute Secretary, Anne Lukeman, for their support during another challenging year.

TREASURER'S ANNUAL REPORT

Again, during this year, the smooth running of the Club has been interrupted by COVID-19 lockdowns but we did manage to have seven face-to-face meetings in the Ajani Hall and three meetings on Zoom. Members were able to enjoy a fee-free year.

We paid the full Member Capitation Fee of \$15 per Member from **Club Funds** to PSPL and received some Membership and Joining Fee income from several new Members. As a consequence, we find ourselves in a reasonable financial position and are able to offer Members a reduced Annual fee of \$30.00 instead of the previous \$35.00 for the 2022/23 year (payable in March 2022).

Activities were largely curtailed, postponed or cancelled. However, an overall surplus of \$650.00 was achieved and transferred to Club Funds.

The **Craft Group** finances continue to chug along nicely, ending the year with cash-in-hand of \$7,556.13. The balance of the Manningham City Council "Grass Roots Recovery Grant" of \$3,600.00 was spent by July, at which time I submitted a report to the MCC.

In May I applied for and received a very welcome \$1,000.00 "good2give" Grant from the Stockland CARE Grants Team. This was discharged in July, necessitating the submission of another completion report. It was deemed inappropriate to apply for any new Grants while there was such a substantial balance, but this may need to be reviewed later in the 2022/23 financial year. Keep up the good work, girls!

The current comfortable position is due in part to a very welcome donation of \$2,226.60 by June Duncan, money which she had once again raised at Hayville Retirement

Community. Many thanks to June! There have also been a few very much appreciated individual donations by Club Members during the year.

I have continued in my practice of inserting my Monthly Treasurer's Report in the Newsletter in those months when we were unable to have face-to-face meetings.

Notes to Financial Statements for the year ended 31st January 2022

As a result of the COVID-19 pandemic:

- * The Club had only seven face-to-face meetings and three meetings by zoom.
- * Members were able to have a fee-free year.
- * The Committee has decided to reduce the annual Membership Fee from \$35 to \$30 for the year 2022/23 as there was \$6,910 on hand at 31st January, 2022.

We paid the full Capitation Fee of \$15 per Member from **Club Funds** to PSPL and received some Membership and Joining Fee income from new Members.

Activities were largely curtailed, postponed or cancelled. However, an overall surplus of \$379.20 was achieved and transferred to Club Funds.

The Craft Group ended the year with cash-in-hand of \$7,556.13. The balance of the Manningham City Council "Grass Roots Recovery Grant" of \$3,600 was spent by July. In May we received a \$1,000 "good2give" Grant from the Stockland CARE Grants Team which was discharged in July. The Craft Group also received a donation of \$2226.60 from June Duncan, money which she had once again raised at Hayville Retirement Community. There have also been a couple of individual donations by Club Members during the year.
